- 1. Vendor/Exhibitor understands that space is not guaranteed until they return this completed form and it is received and accepted by THE ONYX & BREEZY FOUNDATION; THE ONYX & BREEZY FOUNDATION reserves the right to deny participation to any Vendor/Exhibitor for any reason.
- 2. Vendor/Exhibitor is responsible for obtaining any necessary permits. Please contact the Wayne Health Department if you have any questions about the need for a permit.
- 3. Vendor/Exhibitor will obtain their own insurance for loss or damage to their property and goods at their own expense.
- 4. Vendor/Exhibitor will set-up its space no earlier than 8:00am, and must be fully set-up by 9:30am. Vehicle(s) must be parked in the area designated for vendors. The vendor coordinator will direct you when you arrive.
- 5. Vendor/Exhibitor is responsible for supplying its own set-ups and displays, including tents, tables and chairs if desired.
- 6. Vendor/Exhibitor must offer for sale only items appropriate for a family event; THE ONYX & BREEZY FOUNDATION reserves the right to request that any Vendor/Exhibitor remove from sale and public display any items that THE ONYX & BREEZY FOUNDATION finds objectionable for any reason.
- 7. Vendor/Exhibitor agrees not to offer for sale any items detrimental to the public, such as: fireworks, sparklers, drugs, drug paraphernalia, etc. THE ONYX & BREEZY FOUNDATION reserves the right to inspect all merchandise, whether for sale or exhibit, and limit its sale or display; THE ONYX & BREEZY FOUNDATION reserves the right to ask a Vendor/Exhibitor to vacate its space if items are found to be unsuitable, and any fees paid to THE ONYX & BREEZY FOUNDATION will be forfeited.
